Allowable Medical Expenses for SNAP Application Expenses & Deductions





SNAP allows households to deduct unreimbursed medical expenses over \$35 per month from their income in calculating their net income for eligibility purposes. The medical expense deductions listed below and verified by the Oklahoma Department of Human Services (DHS) can often increase the amount of SNAP benefits received.

Please use this worksheet to select actual expenses you have in your household, and then write the dollar amount for each expense. DHS determines what deductions are appropriate based on their review of each individual application and proof provided.

8. Service Animals

Deductions are allowed for costs associated with any service animal specially trained to serve the needs of a person who is elderly or has a disability. All costs associated with the animal's care such as food, veterinary bills, and medicines are deductible.

• If the animal has not been specially trained, it is not a service animal, and you cannot deduct its expenses. Specific types of training, credentials, or certifications are not required, but the animal must be specially trained to perform a function that the person who is elderly or has a disability is not able to readily perform on their own.

9. Reasonable cost of Transportation and Lodging to Obtain Medical Treatment or Services

☐ Transportation costs to obtain medical treatment are deductible and include use own vehicle, public transportation, or by a non-household member.

□ Lodging expenses allowed when the member must spend the night away from home for medical services.

• Requires proof of medical treatment and receipts of the lodging expense; does not include meals or other incidentals.
